Saory Spence is the daughter of Grant Spence. Saory plans to attend El Paso Community College.



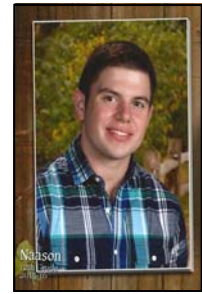

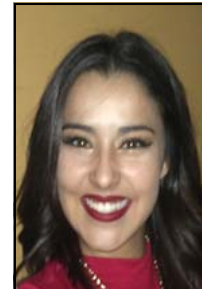
